ARTICLE I PURPOSE

Section 1.0 This Local Law is enacted for the purpose of amending Local Law No. 3 of 2004, Town of German Subdivision Regulations.

ARTICLE II AMENDMENT

Section 2.0 Article 200, section 203(a) of Local Law No. 3 of 2004, Town of German Subdivision Regulations, is hereby amended to read as follows:

“203. Deposit of Funds And Payments of Fees.

- A. Simultaneously with the filing of an application for approval of a development and prior to the commencement of any construction of buildings, highways, drainage facilities, utilities or parks therein, the applicant or developer shall deposit with the Town Supervisor a sum of money as determined in consultation with the Town’s consulting engineer, by the requirements of this law and the design of the proposed subdivision, which sum shall be used to pay costs incurred by the Town for engineering and legal services pertaining to the development as further detailed in Section 203B, C and D below.”

ARTICLE III
EFFECTIVE DATE

Section 3.0 This local law shall take effect and be in full force upon its filing with the Office of the Secretary of State of New York.




